

Shri Ghanhyam Jha proposed the name of Shri Abhay Anand as Joint Secretary and it was recorded by Shri D N Jha.


All MC members agreed with the nominations and hence the newly constituted committee nominated the below office bearers with consensus:






After the oath taking ceremony all former MC members & the invited residents wished the members of the newly constituted Managing Committee for the maintenance and development of the Society.
